INVESTMENT OBJECTIVE AND STRATEGIES

The investment objective of the Portland North American Alternative Fund (the Fund) is to achieve, over the long term, preservation of capital and a satisfactory return through focused investing in long security positions. The Fund seeks to provide capital growth by primarily investing in a portfolio of equities, American Depository Receipts, and which may also invest in exchange traded funds (ETFs).

The Fund is considered an "alternative mutual fund" according to National Instrument 81-102, meaning it is permitted to use strategies generally prohibited by conventional mutual funds, such as the ability to invest up to 20% of its net asset value in securities of a single issuer (rather than 10% for conventional mutual funds); the ability to invest up to 100% or more of its net asset value in physical commodities either directly or through the use of specified derivatives; borrow, up to 50% of its net asset value, cash to use for investment purposes; sell, up to 50% of its net asset value, securities short (the combined level of cash borrowing and short selling is limited to 50% in aggregate); and aggregate exposure up to 300% of its net asset value.

RISK

The overall risk level has not changed for the Fund. Investors should be able to accept a medium level of risk and plan to hold for the medium to long term.

RESULTS OF OPERATIONS

For the six months ended March 31, 2023, the Fund's Series F units had a return of 12.86%. For the same period, the MSCI Canada Index (the Index) had a return of 10.37%. For the full period since inception of the Fund on April 17, 2020 to March 31, 2023, the Fund's Series F units had an annualized return of (2.12%). For the same period, the Index had an annualized return of 14.29%. Unlike the Index, the Fund's return is after the deduction of its fees and expenses.

The Fund's net asset value at March 31, 2023 was \$1.6 million. Asset mix at March 31, 2023 was common equities, 135.1%; and cash and

other net assets (liabilities), (35.1%). By sector, assets were invested in financials, 90.2%; industrials, 22.1%; communication services, 18.1%; consumer discretionary, 3.8%; energy, 0.9%; and cash and other net assets (liabilities), (35.1%). By geography, assets were invested in securities of issuers based in Canada, 56.3%; United States, 44.5%; Cayman Islands, 22.1%; United Kingdom, 12.2%; and cash and other net assets (liabilities), (35.1%).

Over the last year, interest rates rose sharply as central banks attempted to reduce undesirably high rates of inflation. These higher interest rates depressed the values of longer-term bonds and other fixed income securities and contributed to much lower equity markets that fell sharply from their highs. Much of those declines appear to have run their course by September 30, 2022. That is why, for the six months ended March 31, 2023, the Fund enjoyed positive performance as described above. The two largest contributors to the Fund's performance in that period were Citigroup Inc. and Great-West Lifeco Inc. The two largest detractors from the Fund's performance in the period, whose impacts were just slightly negative, were Meta Platforms, Inc. and Suncor Energy, Inc.

RECENT DEVELOPMENTS

As at March 31, 2023, the Fund's common equity investments comprised 135.1% of its net asset value. The Fund is permitted to have an equity weight as high as 150% of its net assets (facilitated by the use of margin borrowings). Subject to identifying suitably attractive investment opportunities, we are prepared to increase the Fund's common equity weight through the use of additional margin borrowings. A higher common equity weighting, if implemented, would be expected to enhance future fund performance.

On April 26, 2023, the Manager announced that the Fund will be terminated on or about June 30, 2023.

LEVERAGE

When a Fund makes investments in derivatives, borrows cash for investment purposes, or uses physical short sales on equities or other portfolio assets, leverage may be introduced into the Fund. Leverage occurs when the Fund's notional exposure to underlying assets is greater than the amount invested. It is an investment technique that magnifies gains and losses. Consequently, any adverse change in the value or level of the underlying asset, rate or index may amplify losses compared to those that would have been incurred if the underlying asset had been directly held by the Fund and may result in losses greater than the amount invested in the derivative itself. Leverage may increase volatility, may impair the Fund's liquidity and may cause the Fund to liquidate positions at unfavorable times.

To help achieve its investment objective, the Fund exercised leverage through borrowing. During the six-month period ended March 31, 2023, the minimum amount of borrowing exercised by the Fund was \$52,918 and maximum was \$583,318 (March 31, 2022: minimum \$nil, maximum \$1,287,653).

RELATED PARTY TRANSACTIONS

The Manager is responsible for the day-to-day operation of and for providing investment management services to the Fund. The Manager receives a fee for providing these services. This is calculated daily based

on the net asset value of the Fund and paid monthly. During the sixmonth period ended March 31, 2023, the Manager received \$9,280 in management fees from the Fund, net of applicable taxes (March 31, 2022: \$14,699).

The Manager is entitled to receive a performance fee, calculated and accrued on each business day and paid monthly. The performance fee is equal to 10% of the amount by which the net asset value of the series of units on that business day exceeds the high water mark. During the six-month period ended March 31, 2023, the Manager received \$nil performance fees from the Fund, net of applicable taxes (March 31, 2022; \$nil).

Any administrative services paid for or provided by the Manager are charged to the Fund and are grouped and presented by expense type in the statements of comprehensive income (loss). Depending on their nature, some expenditures are allocated to the Fund based on a variety of methods including net asset value or actual costs incurred. During the six-month period ended March 31, 2023, the Manager was reimbursed \$3,900 for operating expenses incurred on behalf of the Fund, including amounts paid to affiliates, net of applicable taxes (March 31, 2022: \$6,567). The Manager absorbed \$83,901 of operating expenses during the six-month period ended March 31, 2023, net of applicable taxes (March 31, 2022: \$75,715). Affiliates of the Manager provide administrative services associated with the day-to-day operations of the Fund. These affiliates of the Manager were reimbursed \$446 during the six-month period ended March 31, 2023 by the Fund for such services (March 31, 2022: \$464).

The Manager and/or its affiliates and key management personnel of the Manager and their family (collectively referred to as Related Parties) may invest in units of the Fund from time to time in the normal course of business. Transactions to purchase or redeem units are made at net asset value per unit. Standing instructions from the independent review committee (IRC), as described below, were not required or obtained for such transactions. As at March 31, 2023, Related Parties owned 349 shares of the Fund (March 31, 2022: 338).

The Fund has received standing instructions from the Fund's IRC. The standing instructions constitutes a written recommendation from the IRC that permits the Manager to proceed with specific action(s) set out in the standing instructions on an ongoing basis as detailed in the annual IRC Report to Securityholders. The standing instructions are designed to ensure that the Manager's actions are carried out in accordance with National Instrument 81-107 - Independent Review Committee for Investment Funds and the Manager's policies and procedures in order to achieve a fair and reasonable result for the Fund. The IRC reviews reports periodically, at least annually, which assess compliance with applicable conflicts of interest policies and standing instructions.

Except as otherwise noted above, the Fund was not a party to any related party transactions during the six-month period ended March 31, 2023.

The Board of Directors of the Manager is responsible for reviewing and approving the financial statements and overseeing management's performance of its financial reporting responsibilities.


Past Performance


Year-By-Year Returns

Management Fees

The Manager is responsible for the day-to-day management and administration of the Fund. The Manager monitors and evaluates the performance of the Fund, pays for the investment management services of the portfolio adviser and arranges for the administrative services required to be provided to the Fund. As compensation for its service, the Manager is entitled to receive a fee, payable monthly, calculated based on the average daily net asset value of the Fund.

Explanatory Notes

- 1. a) The information for March 31, 2023 is derived from the Fund's unaudited interim financial statements. For the remaining periods, the information is derived from the Fund's audited annual financial statements prepared in accordance with International Financial Reporting Standards. The net assets per series presented in the financial statements may differ from the net asset value calculated for fund pricing purposes.
 - b) The inception date of Series A and Series F units of the Fund was April 17, 2020.
- Net assets and distributions are based on the actual number of units outstanding at the relevant time. The increase/decrease from operations is based on the weighted daily average number of units outstanding over the financial period.
- Distributions are paid out in cash/reinvested in additional units of the Fund, or both.
- 4. This is not a reconciliation of the beginning and ending net assets per unit.
- 5. The management expense ratio (MER) is based on total expenses (excluding foreign withholding taxes, commissions and other portfolio transaction costs but including management fee distributions paid to certain unitholders in the form of additional units) for the stated period and is expressed as an annualized percentage of daily average net asset value during the period. The Manager may absorb certain expenses otherwise payable by the Fund. The amount of expenses absorbed is determined annually at the discretion of the Manager.

The Fund may hold investments in ETFs and the MER is calculated taking into consideration the expenses of the Fund allocated to the series including expenses indirectly attributable to its investment in ETFs divided by the average daily net asset value of the series of the Fund during the period.

- 6. The trading expense ratio (TER) represents total commissions and other portfolio transaction costs expressed as an annualized percentage of the daily average net asset value of the Fund during the period.
 - The TER is calculated taking into consideration the costs attributable to its investment in ETFs.
- 7. The Fund's portfolio turnover rate indicates how actively the Fund's portfolio advisor manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to a fund buying and selling all of the securities in its portfolio once in the course of the period. The higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Portfolio turnover rate is calculated based on the lesser of the cumulative cost of purchases or cumulative proceeds of sales divided by the average market value of the portfolio, excluding short-term investments.
